JOB DESCRIPTION



Job Title: Teaching Assistant (SEN)

Salary: SAT B
Responsible to: SENDCO

Purpose of the Job:

To work with teachers to support teaching and learning, providing general and specific assistant to students and staff under the direction, guidance and direct supervision of the classroom teacher.

Note on the use of the job description: This job description may be used for Teaching Assistants providing 1:1

support to a designated student.

Key Accountabilities:

- Working with individuals or small groups of students in the classroom under the direct supervision of teaching staff and provide feedback to the teacher.
- Support students to understand instructions, support independent learning and inclusion of all students.
- Support the teacher in behavior management and keeping students on task.
- Support students in social and emotional well-being, reporting problems to the teacher as appropriate.
- Prepare and clear up learning environment and resources, including photocopying, filing and the display and presentation of students work and contribute to maintaining a safe environment.

Teaching Assistants in this role may also undertake some or all of the following:

- Record basic student data.
- Assist with break-time supervision.
- Assist with escorting students on educational visits.
- Supporting students in using basic ICT.
- Invigilate exams and tests.

Other Duties and Responsibilities

- In additional all members of the school community are expected to:
- Display a commitment to child protection and safeguarding. Reporting to the Head of School any behaviour by colleagues, parents and children which raises concern.
- Comply with policies and procedures relating to child protection, health, safety, welfare and security, confidentiality and data protection, reporting all concerns to the appropriate person.

The main duties and responsibilities are indicated above. Other duties of an appropriate level and nature may also be required as directed by the SLT.

- Certificates of educational or professional qualifications that are necessary or relevant for the post

Conditional Offer
